This has reference to our earlier communiqués regarding the forthcoming **Business Delegation to Australia**, organized by The Bengal Chamber of Commerce and Industry, in association with **Australian Trade Commission (Austrade)**.

This is to inform you that the date of the Delegation has been rescheduled (14th July 2018- 21st July 2018) (The commencement date will remain the same. The tenure may vary with the requirements of the meeting).

The objective of the delegation is to organize **focused B2B meetings**.

Potential sectors, identified for the delegation, are:

The delegation will visit Sydney and other city(ies) of relevance according to the composition of the delegation.

The Bengal Chamber and Austrade are in dialogue with **State and Federal Government agencies and probable organizations to organize B2B meetings and facilitate site visits to facilities/institutes in Sydney other city(ies), as mentioned above, which would make the delegation meaningful for the delegates.**

The expenditures of the delegation are to be incurred by the delegate members on actuals.

The estimated costs are (approximately):

- **Airfare:** Rs. 65,000/- - 85,000/- (as per the availability of flights at the time of booking).
- **Accommodation:** Rs. 60,000/- - 90,000/- (depending on the category of the hotels).
- **Local travel:** Rs. 20,000/- (individually, the cost may be reduced by sharing).
- **Intercity travel:** Will depend on the requirement of the travel.

Additionally, Secretariat fee of Rs. 25,000/- + GST has been affixed to defray the cost of organizing the delegation including meetings and facilitation of logistics.
