- Successful bidder will have to pay VAT, TAX and other payable fees as per Customs rules for the duty free imported materials to be taken out to the Domestic Tariff Area (DTA).
- Building structure, inventoried machineries, furniture and other materials will be sold in a single lot as per auction schedule.
- An amount of 10% as security money (refundable) of the total bidding value in the form of Pay order/Bank Draft from any Scheduled Bank has to be deposited in favor of "BEPZA" along with the Auction documents. Auction documents without security money will be treated as rejected.
- Materials under the inventory list may be seen in any working days up to 24.06.2018 during office hour. Information regarding the visit and the list of materials may be collected by contacting with the General Manager, Uttara EPZ.
- Successful Auctioneer will have to pay applicable income Tax and VAT on the full amount of the Auction quoted price along with remaining 90% within 15 days to BEPZA, if the tender is accepted. Accordingly the delivery of building structure, inventoried machinery, furniture and other materials will have to be taken as per Customs & BEPZA rules.
