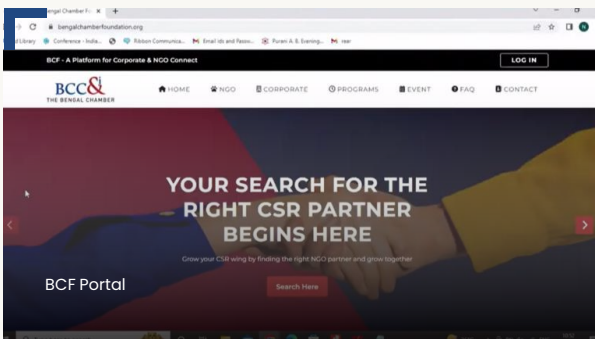

Incubation

The WEBEL-BCC&i Tech Incubation Centre is a joint initiative of The Bengal Chamber of Commerce & Industry and West Bengal Electronics Industry Development Corporation (WEBEL) supported by Bandhan Konnagar (a CSR implementing organization of Bandhan Bank Ltd.). The Chamber started the journey of incubation of technology startups in 2019. Eventually other corporates like Hewlett Packard Enterprise, Web Prism IT Solution, Google Cloud, Amazon Web Services, 100X.VC and Seven Boats have also joined this initiative with varied offerings. The main objective of the incubation centre is to create an ecosystem that will foster, support innovation and knowledge-based entrepreneurship in leading to the creation of wealth, employment and social value through successful ventures. From the inauguration of this incubation centre on 1st June 2019, till date we have incubated a total of 82 Start-ups. The Incubation Centre has a total capacity of 16 seats. The center also provides virtual incubation. At present there are 18 incubatees associated with the centre.

One of the primary offerings of the Webel-BCC&i Tech Incubation Centre to the associated Startups is providing them with platform in the national level seminars/conclaves organized by The Bengal Chamber to showcase the Startups in a larger forum so that they get the exposure and opportunity to network with marquee speakers and eminent leaders of the industry and also a larger network.

IT and IT Entrepreneurs & eCommerce

The Chamber is deeply connected with Tech Industry. The Chamber has a dedicated IT Committee under the aegis of which vibrant initiatives are taken up, which over the years, bring together technology providers, users, academia, startups, incubators, policy makers and the other stakeholders of technology to share applications, disseminate knowledge on cutting edge technologies, network and exchange dialogues for collaborations. Our annual Business IT Conclave under the aegis of BCC&i IT Committee focuses to connect with national and international Technology leaders showcasing the potential of Bengal in emerging technologies with availability of intellectual resources and promising Startups.

The Chamber also has a newly curated IT Entrepreneurs and eCommerce National Committee, which is aimed to promote regional ecosystem of IT Entrepreneurship and eCommerce, facilitating appropriate connect of the stakeholders with potential market, collaborators, funding and other catalyzers for growth. The scope of engagements of the Committee is pan India, to begin with, and may also be internationally for creating appropriate interface.

The first edition of our annual "Tech-E-Summit" was held in Bengaluru in 2023, wherein prominent investors from Kolkata, Bengaluru and Mumbai were connected with promising startups from West Bengal. It also created a platform for Startups and Entrepreneurs from Bengal and Karnataka to discuss possible areas of collaborations, after which the Chamber received collaboration offers from various entities including banks and legal firms for supporting technology Startup Ecosystem. A sizeable delegation of Technology Entrepreneurs, Startups, VCs and Investors notably with the IT Minister of West Bengal travelled to Bengaluru to be a part of the Summit.

Continuing the spirit of the great success of connecting with the Startup community at 1st Edition of Tec-E Summit, BCC&i organized the first edition of Biz Tech Startup Quiz, in association with Manipal Academy of Higher Education (MAHE) Bengaluru in March 2024. This was a unique platform, which offered Startups to network with each other and helped to connect with Investors and successful entrepreneurs. 40 teams consisting of Startups and Startup enthusiasts participated from Hyderabad, Chennai, Mumbai, Cochin and Bengaluru.
