Environment and Energy Conclave 2008

22nd and 23rd August 2008, ITC Sonar, Kolkata

For the first time ever, an Energy Conclave was presented by the Bengal Chamber of Commerce and Industry in the Eastern Region. Held over two days (22nd and 23rd August 2008) at the ITC Sonar, Kolkata, the Conclave discussed the avenues of addressing climate change, policy measures, increasing efficiency of energy consumption, financing new projects through the CDM route, benefits of energy management and energy audit in industries, the new options in energy, new technologies in mining, renewables, etc. Senior Government functionaries (Centre and State), well-known industry experts and consultants addressed the event.

Indeed, the event was presented on the scale of a Summit and had participation from leading personalities from Government, Industry, Academia, and NGOs. It was, quite literally, a melting point of thoughts, ideas and experiences.

Yet, it was an event of the industry, for the industry and by the industry. The Conclave enabled each participating organization and delegate with a unique opportunity to network with the thought leaders and other industry leaders in energy, power and environment and brought participants closer to their colleagues in industry, academia and the Government in discussing the implications of climate change and related energy issues for industry.

Shri Anil Razdan, IAS, Secretary to the Government of India, Ministry of Power and Dr. Kirit Parikh, Member, Planning Commission, along with Shri Sunil Mitra, IAS, Additional Chief Secretary, Government of West Bengal, were the Guests of Honour during the Inaugural session. Dr. Parikh, the architect of the Integrated Energy Policy, was honoured by BCCI at the Conclave as the "Energy Thought Leader of the Year" for his pioneering contribution to the field of energy research and energy policy in the country. The theme of the keynote address was, "Climate Change and India's Economic Development - The role of the Integrated Energy Policy". In this session, the two stalwarts of the energy and environment field largely talked about the efficiency issues in the Government departments, the private public partnerships in the area of energy, how the Government could develop the overall situation by welcoming more MNCs in our country. Dr. Parikh, during his address, mostly talked about Climate Change and its impact on environment and our economy at large, what should be the objective of all the Governments to increase social well being, global environmental issues and goal of development conflict, range of commercial energy requirement and domestic production, India's hydro carbon reserves, renewable energy resources and most important the challenges of the 11th Five Year Plan.

Following the inauguration, the session on "Climate Change and Industry - Impact and Measures" was chaired by Shri Malay K De (IAS, Chairman & Managing Director, West Bengal State Electricity Distribution Company). The themes that were covered under this session were, Industrial Operations in the face of Climate Change -

Maximum Impact Areas and Implications; Prevailing Deal Structures in Carbon Finance and Focus Carbon - Financing Industrial Growth (Case Studies). The speakers included Senior Executives from PwC, Ernst & Young, CESC and ITC Limited. The speakers in this session mainly focused on Climate Change, Climate Change Risks, Carbon Footprints, Carbon Markets, Carbon Transactions, Carbon Finance, etc.

The next session focused on "Power - Creating Opportunities for Sustainable Industrial Growth" and themes like Energy Management and Energy Audit in Industry in the Age of Energy Conservation, Energy Efficiency in Transmission and Distribution System, Managing Energy at Integrated Steel Plants, Moving Markets for Energy Efficiency were covered. Mr. S. K. Dasgupta, Vice Chairman-Technical, Development Consultants Private Limited chaired the session. Noted personalities from Bureau of Energy Efficiency, Ministry of Power, Government of India; Senior Executives from WBSEDC, SAIL (DSP) and Thermax were the speakers.

The second day began with a brainstorming session on Energy Options in India - Fossil Fuel and New and Renewable Sources, which was chaired by Prof. Sujay Basu, Former Director, School of Energy Studies, Jadavpur University. Prof. Basu gave an overview on the energy options in India and what could be new technologies in this field. Thereafter, Shri S P Gon Choudhuri, Managing Director, West Bengal Green Energy Development Corporation made a detailed presentation on renewable energy options. The other speakers (all top executives) were from Thermax Limited, Vestas Wind Technology India Pvt. Ltd., Selco International Limited, GP Green Energy Systems Pvt. Ltd. and PTC India Limited. They touched upon areas like Solar Energy - Heating & Cooling, Opportunities in Renewable Energy, Waste to Energy, Biomass Gasification and Project Financing of RE Projects.

Shri P. S. Bhattacharyya, Chairman, Coal India Limited, chaired the following session, "The Coal Story". The session visited different fields related to Coal, e.g., New Coal Technologies, Challenges for Development of Mining in India to cater to Utilities and Large Process Industries, Coal Beneficiation for Clean Technologies and Coal Bed Methane. The speakers present in the session were senior executives from the EMTA Group of Companies, senior academics from Bengal Engineering and Science University, Shibpur and the Advisor-Projects, Ministry of Coal, Government of India.

The concluding session was entitled "Tomorrow's Choice". Mr. Alope Mookherjee, Chairman, Flakt (India) Limited & Immediate Past President, BCCI chaired the session, which focused on the future path that one should follow given that Global Warming was a reality.

The programme was attended by over 200 delegates and the Chamber received compliments from all participants and sponsoring entities on organizing such a relevant programme, which focused on on-the-ground issues for industry.

Environment and Energy Conclave 2009

28th & 29th August 2009, ITC Sonar, Kolkata

The Environment and Energy Conclave, the Bengal Chamber's signature event and the only event of its reach and dimensions in the environment and energy spheres in the Eastern Region, was organized by the Energy and Environment Sub-Committee of the Chamber on 28th and 29th August 2009 at the ITC Sonar, Kolkata. The Conclave was addressed by speakers who were the veritable "who's who" of the environment and energy spheres – from the worlds of policy, fundamental and applied research, technology and business. The theme of the Conclave was, 'Solutions for Building Competitive Advantage'. Shri Shyam Saran, Prime Minister's Special Envoy; Dr. Bikash Sinha, renowned scientist and Former Director, Saha Institute of Nuclear Physics and Variable Energy Cyclotron Centre and Mr. Sanjay Mark Wadvani, Deputy High Commissioner of UK in Kolkata addressed the inaugural session. They apart, some of the other speakers included Dr. G D Gautama, IAS, Principal Secretary, Department of Power and Non-Conventional Energy Sources, Government of West Bengal; Dr. N R Banerjea, Chairman, West Bengal Electronics Industry Development Corporation Limited (WEBEL)

and Dr. R R Sonde, Chief Technology Officer and Executive Vice President – Research, Technology & Innovation, Thermax Limited.

There were also speakers from Canada (presenting on fuel cell technology) and Germany (speaking on energy management by radio). There were many other topics and senior speakers from all over India who addressed the Conclave.

The focus of this Conclave was to create a forum for the best minds in environment and energy to meet and brainstorm on issues that were critical for industrial production and sustenance of business and the economy. Through such deliberations the Chamber endeavoured to create awareness on global environmental issues, discuss the importance of energy conservation and increasing process efficiency as well as minimizing the climatic impact of industrial operations while not deviating from the profit motive.

Indeed, the Conclave was a most necessary event for industry, Government and academia in the context of the present realities. The world is in the throes of a recession never before seen since the Great Depression of 1929. To make matters worse, the threat of climate change is very real and its impact would be most severely felt right here in Kolkata, one of the world's most vulnerable regions. In every crisis there lies an opportunity and the present-day environmental threat too is giving rise to technologies, practices and innovations, which, if applied appropriately, can have an immense impact on increasing the competitive advantage of firms. This year, the event was designed such that delegates would have the greatest takeaways in the areas of environmental / energy management, which would also benefit business operations and organizational strategy in the context of environmental threats and compulsions. Simultaneously, the Chamber also discussed Climate Change, which would be the most dominating issue in the immediate future and threaten the very existence of our children and future generations, unless we do something about it now.

The Conclave enabled participants to brainstorm together and learn from thought leaders how to harness the new opportunities, stay away from the

Environment and Energy Conclave 2010

27th-28th August 2010, ITC Sonar, Kolkata

The Energy and Environment Committee of the Bengal Chamber held the third edition of the now-iconic two-day Environment & Energy Conclave on 27th and 28th August 2010 at the ITC Sonar, Kolkata. The Conclave is the leading forum for discussing and brainstorming global and local environmental issues like climate change and the response of business, the government and civil society. The Bengal Chamber has been holding this Conclave for quite some time and this is the Chamber's signature event. This year the theme was, "From Copenhagen to Mexico: Business Sustainability in Emerging Scenarios". The objective was to provide an even larger forum than the previous years for visiting the scenarios governing the Indian economy and industry with the Climate negotiations this year in the background.

The Conclave was the regional forum for industry leaders and CEOs to exchange best practices in energy efficiency, environmental management and enhancing funds inflow for Indian businesses through the carbon market route. The Conclave showcased the winning strategies from global and national corporate leaders and how these could be dovetailed into today's manufacturing entities and have a direct impact on enhancing profitability. As a leading Chamber of Commerce, our concern is with respect to the cost of adaptation to Climate Change for the country, which has been estimated at 2.6 per cent of India's GDP. Importantly, the Conclave addressed and tried to solve the specific challenges facing Indian industry in the realm of cutting the emission intensity by 20-25%. This was a huge challenge, especially since our growth momentum could not be compromised with.

The Inaugural Session focused on the overarching implications of the negotiations for India's economy and also included overseas perspectives and addresses on climate change mitigation efforts through a collaborative approach. The National Mission for Enhanced Energy Efficiency, an integral part of the National Action Plan on Climate Change, was also covered. The speakers were Ambassador C Dasgupta, Distinguished Fellow, TERI, Dr. Ajay Mathur, Director General, Bureau of Energy Efficiency, His Excellency Peter Varghese, High Commissioner of Australia in India and Mr. Sanjay Wadvani, Deputy High Commissioner of Britain in

Kolkata. Thereafter, six technical sessions were held. Focus was on climate change and business sustainability, IPR and climate change, alternative energy in the East, international perspectives, Indian power paradox and sustainability in climate change initiatives. The sessions featured two Ashden Award winners, namely, Mr. A Saji Das, Director, BIOTECH Renewable Energy Private Limited and Shri S P Gon Chaudhuri, Managing Director, West Bengal Green Energy Development Corporation. Other speakers on green technology and renewable initiatives included Shri Shailendra Shukla, Director, Chhattisgarh Renewable Energy Development Agency. Mr. Alope Mookherjea, Hon. Consul Sweden & Chairman, Flakt (India) Limited, Mr. Clinton Brown, Consul for Political and Economic Affairs (USA), Mr. Fergus Auld, First Secretary, Climate Change & Energy, British High Commission, DFID, Dr. R R Sonde, CTO and Executive Vice President (Research, Innovation & Technology), Thermax Limited, Dr. P Ram Babu, CEO, General Carbon Advisory Services, Mr. S K Dasgupta, Vice Chairman, Development Consultants Pvt. EBTC B2B FORUM ENVIRONMENT AND ENERGY CONCLAVE 2011

25TH AUGUST AND 26TH - 27 TH AUGUST 2011

ITC SONAR, KOLKATA



The Energy and Environment Committee of the Bengal Chamber of Commerce and Industry organized the fourth annual Environment and Energy Conclave 2011 on 26th and 27th August 2011 at the ITC Sonar, Kolkata. The Conclave is the largest and most relevant forum to discuss Climate Change mitigation action for businesses and the economy without deviating from the profit motive and in fact, while enhancing profitability. The Conclave has also assumed the profile of an annual international meet, which is increasingly utilized by speakers, delegates and sponsors to exchange, share and learn about best practices in energy and environment management cutting across the boundaries of business domains, academic research and policy framework.

This year's Conclave brought together thought leaders in energy policy, senior officials of the Government, overseas Governments and Embassies, leading academics and CEOs from all over the country with delegates and speakers from India and abroad spanning two continents, North America and Europe.

In 2011, our theme was, "Sustainable Development and Driving Technology Advances in Future Energy". The Conclave promoted innovation and investment opportunities surrounding future energy technology including renewable energy. It also presented a most relevant business platform bringing together project owners and solution

providers with stakeholders from both the public and private sectors. The focus was to present solutions for a modern and sustainable energy system.

This year's event also stood out because of two reasons. The European Business and Technology Centre (EBTC), a premier organization financed by the European Union and coordinated by the European Chamber of Commerce (EUROCHAMBRES) was the Chamber's CleanTech Partner and Frost and Sullivan was the Knowledge Partner. Over 250 delegates from corporates across the country, NGOs and members of the academia attended the two-day Conclave.

EBTC had contacted the Chamber and signed a MoU in February focusing on promoting JVs and partnerships between Indian and European companies on Clean Technology. Since then, for the first time ever in the Eastern Region for EBTC, and through the exclusive efforts of the Bengal Chamber, Hari Machines Limited, an Indian company based in Kolkata and RAFAKO S.A., a Polish company signed a technology partnership in August during the Conclave. The Chamber has received tremendous mileage in the EU for this development. In fact, from 25th August to 27th August, the last two days coinciding with the Conclave, EBTC had brought an European delegation exploring tie-ups in West Bengal on clean technologies. The Bengal Chamber organized the local programme with EBTC

and the delegation was also part of the Conclave. This was a first-of-its-kind B2B meet that was organized on 25th August at the ITC Sonar. The programme was a great success with close to 150 participants.

Frost and Sullivan authored a paper on the Conclave theme, which was a comprehensive document presenting the existing scenario and suggesting solutions that need to be looked at seriously by various Energy, Environment, and Policy planners of the world and India for a sustainable future. It is imperative that these solutions are integrated at the earliest into the future energy plans of countries. Support from the policy makers, the Government, financial bodies, and commitment from the people and the industry is required for their early adoption. The paper was prepared by Mr. Pinaki Bhadury, Vice President – Consulting, Frost and Sullivan who presented his findings during the Inaugural Session. The Conclave was addressed during the Inaugural Session by Shri M K De, IAS, Principal Secretary, Department of Power and Non-Conventional Energy Sources, Government of West Bengal; Dr. Kirit S Parikh, Chairman, Expert Group on Low Carbon Strategy for Inclusive Growth, Planning Commission of India, Chairman, IRADe and Former Member, Planning Commission and an iconic personality in India's economic and energy policy realm and Mr. Poul V Jensen, Director, EBTC.

What has been most important for us is that we have been hosting our Conclave dedicated to the Environment and Green Practices in the world's first CDM-certified hotel, The ITC Sonar, which has been our preferred choice of venue for the four years that we have been holding the Conclave. In fact, ITC has the greenest luxury hotel chain in the world where every hotel is LEED Platinum certified. The ITC Sonar is also the world's first CDM certified hotel. This was, therefore, the most appropriate occasion for the Bengal Chamber to recognize the contribution of ITC Hotels and the leadership role played by ITC and ITC Hotels in contributing to the 'triple bottom line' of economic, social and environmental capital of the country. Energy Sustainability Conclave 2013 (Energy Security – Empowering the Energy Future)

30th - 31st August 2013, ITC Sonar, Kolkata

The Bengal Chamber presented the sixth edition of the annual Environment and Energy Conclave on 30th and 31st August 2013 at the ITC Sonar, Kolkata. Titled, "The Energy Sustainability Conclave 2013", the focus this year was, "Energy Security – Empowering the Energy Future". The Conclave, over the years, has become one of the leading annual platforms in the country for discussing and brainstorming environmental challenges and the response of Business, the Government, the Academia and the Civil Society.

The focus of the Conclave is and has always been Climate Change mitigation and action on the ground in the context of burgeoning needs of incremental energy consumption (albeit efficiently) and the need to adopt sound environmental management practices so as to minimize the environmental footprint, especially in business and industrial operations. A melting pot of experiences and best practices, the Conclave is addressed by thought leaders in energy and environment policy, senior officials of the Government, overseas Governments and Embassies, leading academics and CEOs from all over the country with delegates and speakers from India and abroad. This year apart from CEOs from leading players in energy and senior Government minister and officials, speakers from 4 overseas countries participated.

Worldwide, in the context of a global slowdown and the impasse over Climate negotiations, the need is more than ever to devise strategies, practices and technologies at the micro and macro level, which will help us get over the problem of supply side constraints in energy, the most essential driver of growth. Both conventional and unconventional and renewable sources of energy have their pluses and bottlenecks. In this scenario, to talk about sustainability in the Indian energy sector is to talk about Energy Security of India, an issue of paramount importance for the nation both in the realms of economic and strategic contexts.

Each day presented a different theme and the discussions for the Day focused on the chosen theme for the Day. Day 1 (30th August) had the theme, "Sustainable Energy – An interplay of source

diversification, uninterrupted supply, and low carbon cost effective technology". The Conclave was inaugurated by Shri Manish Gupta, Hon'ble Minister-in-Charge, Power & Non-Conventional Energy Sources, Government of West Bengal following which the audience was captivated with the Inaugural Panel Discussion on "Energy Security: The intersection of demand, energy markets, and supply routes", which was addressed by Dr. Kirit S Parikh, Former Member, Planning Commission and Chairman, Integrated Research and Action for Development (IRADe); Shri Sunil Mitra, Former Revenue and Finance Secretary, Government of India and Former Power Secretary, Government of West Bengal and Mr. Phil Marker, Counselor and Head, Energy, Climate and Growth Unit, British High Commission, New Delhi.

Plenary Session 1 was a first-of-its-kind Business Leaders' Panel Discussion on "Energy as corporate security measure: Experiences and insights". The focus was on the fact that while energy efficiency and cost management continue to be the rallying cry for large companies that have created some sort of energy management strategy, the issue of energy security is becoming a larger factor among companies developing a corporate energy strategy. The discussion was chaired by Mr. Sumit Mazumder, Vice Chairman and Managing Director, TIL Limited and Past President, The Bengal Chamber. The high-powered panel comprised of Ms. Nicola Watkinson, Senior Trade & Investment Commissioner, South Asia, Australian Trade Commission; Mr. Sanjib Bezbaroa, Vice President - Corporate EHS, ITC Limited; Mr. Shishir Joshipura, Managing Director & Country Manager, SKF India Limited and Mr. Sandipan Chakravorty, Managing Director, Tata Steel Processing and Distribution Limited.

The next Plenary Session was an Expert Panel Discussion on "Energy, the Environment and Economic Growth". The cultivation of sustainable markets for energy including renewable energy, energy efficiency and natural gas solutions requires an integrated policy approach that includes incentives, standards, stable investment climates, research and development and public education. It also requires a wholesome approach to renewing

the way we think about energy, from a perspective of economic growth, environmental protection, national security and quality of life. The focus of the panel discussion was to bring to board the interplay of energy elasticity of GDP with economic growth trends, the need for and status of evolving environmental regulations and environmental management norms in industrial projects. This unique session was chaired by Mr. Alope Mookherjea, Chairman, Solyvent Flakt (India) Private Limited & Past President, The Bengal Chamber with the panelists being Dr. Suman K Mukerjee, USAEP Environmental Fellow; & Principal, Dean and Senior Professor, Bhavans Institute of Management Studies and Dr. Ketan Shukla, IFS, Deputy Director General, Mahatma Gandhi Labour Institute; Former Secretary, Gujarat Electricity Regulatory Commission. Dr. Mukerjee spoke from the perspective of an environmental economist, while Dr. Shukla addressed in his capacity as a former bureaucrat in a key office in India's leading State in terms of economic development.

Plenary Session 3 was the bridge between Day 1 and Day 2 (31st August) for which the theme was, "Technology for energy security – Making the conventional out of the unconventional". Since the focus of Day 2 was largely on technology issues, Plenary Session 3 dealt with "Power from conventional and renewable sources in a world still dominated by fossil fuels". It is estimated that USD 30 trillion worth of fossil fuels are still buried in the earth and almost 2800 gigatonnes of carbon locked up in fossil fuels underground. Many are saying we can emit another 565 gigatonnes of CO₂ and still keep the warming to 20 C. In the year 2011-12, approximately 31.6 gigatonnes of CO₂ were emitted worldwide. Atmospheric CO₂ concentration during pre-industrial times was 280 ppm, which has risen to above 400 ppm currently. Almost 26% of this increase is attributed to the energy (generation) sector (with 19.4% from industry and 13.1% from transport). Although electricity generation from hydro plants have exceeded expectations due to improved rains, the social cost and the human displacement and high gestation period of hydel projects are bottlenecks at times. This leaves nuclear and renewables. If the former is always embroiled in controversies on safety and technology, the latter is still governed by relatively higher costs. On the brighter side, India has an installed renewable generation capacity of around 12.5% representing

almost 400% increase in the past 5 years alone. The renewable energy sector is seen as a significant player in grid-connected power generation and investments in renewable energy grew by 25% last year. In this background, Mr. Sutanu Ghosh, Managing Director, Ghosh Bose and Associates Pvt. Ltd. made a presentation on, "Mitigation options in Indian power generation", while Mr. Saunak Saha, Manager – Climate Change and Sustainability Service, Ernst & Young LLP talked about "Renewable energy in India – Options, technology and a cost-benefit analysis". The session was chaired by Prof. B K Dutta, Chairman, West Bengal Pollution Control Board.

The Inaugural Session for Day 2 commenced with an address by Dr. Ajay Mathur, Director General, Bureau of Energy Efficiency, Ministry of Power, Government of India who, in keeping with the theme, spoke about "Energy security through innovative technologies in the context of Indian needs and circumstances".

Dr. Mathur's engrossing theme address was followed by the presentation of the Chamber's first ever Young Energy Researcher Award. This year, the Chamber launched this special initiative, through which we would be acknowledging and facilitating the achievements of a Young Energy Researcher for his or her outstanding work at the grass-roots. In 2013, "The Bengal Chamber Young Energy Researcher Award" went to Shri Senthil A Kumar, an outgoing student in the Master of Public Systems Management programme at the Indian Institute of Social Welfare and Business Management (IISWBM). The award was presented to Shri Senthil Kumar for his outstanding achievements in grass-roots energy technology adaptation. Senthil, during his Summer Project, worked at Tirla Kocha, a remote un-electrified village about 26 km from Ranchi. He went to Ramakrishna Mission, Morabadi and met Swami Shashankananda Maharaj, the sevak Secretary of the Ashram. He was guided to choose his Summer Project topic as he was looking for some application work that would bring direct benefits to its users. The plight of the villagers of Tirla Kocha, particularly the children, moved his heart to find a solution and he could implement it by his own efforts and resources. His friends, faculty and Ramakrishna Mission, Morabadi provided him with moral support and guidance, when necessary. He identified a community centre at Tirla Kocha, estimated the demand, designed a suitable Solar Photovoltaic (SPV) System, purchased

the major components from Kolkata, purchased some components, such as sulfuric acid from the nearest market, took them to the site, fabricated and commissioned the SPV system with lights and fans. The system was working in the community centre (a single room hut) and helped the children with light and little amount of air at night and other times when needed in building their character and capacity through studies, yoga, cultural programmes, etc. The monks of the Mission, Professors from IISWBM who visited the site and faculty examiners who evaluated his Summer Project report were all in praise for this extraordinary work.

On the heels of the presentation ceremony came the Power Sector CEO Panel Discussion on, "Power in India – Growth amidst constraints" chaired by Dr. Mathur. The focus was on cost of energy, reliability of energy supply, carbon emissions, regulatory compliance, energy price volatility, predictability and the coming of age of utilities. The bottom line is, because of their energy density and ease of use, fossil fuels remain the best energy source. As opposed to an installed generating capacity addition of 69231 MW target for the 11th Plan, that for the 12th Plan is 118536.6 MW of which 72,340 MW (61%) would be thermal. It is also estimated that in 2012, 2017 and 2030 thermal electricity generation would have a share of 70%, 69% and 58% respectively. India, as we all know, depends greatly on fossil fuel sources, mostly coal. The problem of efficiency, including that of below-average PLF, is omnipresent. In fact, up to December 2012, the all-India thermal PLF (based on coal / lignite based thermal power stations only) for 2012-13 was 69.63% down from 73.32% achieved in 2011-12. Added to this, the problem of availability of coal, the volatile price and the increased dependence on the import of coal are grim reminders of the fact that electricity in India is anything but sustainable. Both the panelists, namely, Dr. Rajiv Mishra, Executive Director, PTC India Limited and Mr. Siddharth Mehta, CEO, India Power Corporation Limited spoke from their personal experiences and apart from generation, focused on distribution and power trading.

Plenary Session 4 was all about "Experiences in Technology and Energy Efficiency". Chaired by Mr. P S Bhattacharyya, Former Chairman, Coal India Ltd; currently Executive Director Deepak Fertilisers & Petrochemicals Corporation Ltd, Pune, the session

explored best practices in technology development across the world. The speakers were Dr. Ing.Jörg-W. Fromme, Managing Partner, DFIC, Germany (Former Head of International Division WestLB Group; Former Chairman of Board of German Russian Consultant Nishinovgorod; Former Advisor of Jordanian Ministry of Energy and Mineral Resources) who spoke on "Energy efficiency and renewable energy: German experience with increasing competitiveness of industries"; Mr. Alok Goel, Country Manager, India & South Asia Region, Ballard Power Systems, Canada (Techno economic feasibility of hydrogen fuel cells); Shri A K Debnath, Chairman-cum-Managing Director, Central Mine Planning & Design Institute Limited (CMPDI) (Sustainable mining in India); and Mr. Saibal Sen, General Manager and Head of Business Development for India, Steel Plantech India Pvt. Ltd. (Utilization of waste heat recovery in steel industry).

Plenary Session 5 was also the Concluding and the Valedictory Session on "The future of Power in India", which was moderated by Mr. Deb A Mukherjee, Managing Director, Enfragy Solutions India Pvt. Ltd. The Valedictory speaker was Dr. Bikash Sinha, Homi Bhabha Professor, DAE, Former Director, Saha Institute of Nuclear Physics and Variable Energy Cyclotron Centre, Department of Atomic Energy, Government of India. The session discussed the technology, economics and safety aspects of nuclear power with focus on India – from fission to fusion; from reactor to fast breeder technology and the realities and myths of nuclear safety. The session also covered the latest groundbreaking technologies as well as on-the-ground applications, which could be escalated even at the rural level and reduce dependency on conventional fuels. Dr. Sinha spoke from the heart and from his experience as one of the leading physicists in the world. He dispelled the myths surrounding nuclear energy and spoke about the desired fuel mix incorporating renewables and nuclear energy.

The Conclave which was attended by over 250 participants from industries, government agencies, academia, researchers, NGOs and students on each day, concluded with the presentation of special merit certificates to select schoolchildren (including underprivileged children) who had participated in the annual Bengal Chamber Sit n Draw Competition, held on 27th April 2013 on occasion of Earth Day and World Environment Day.

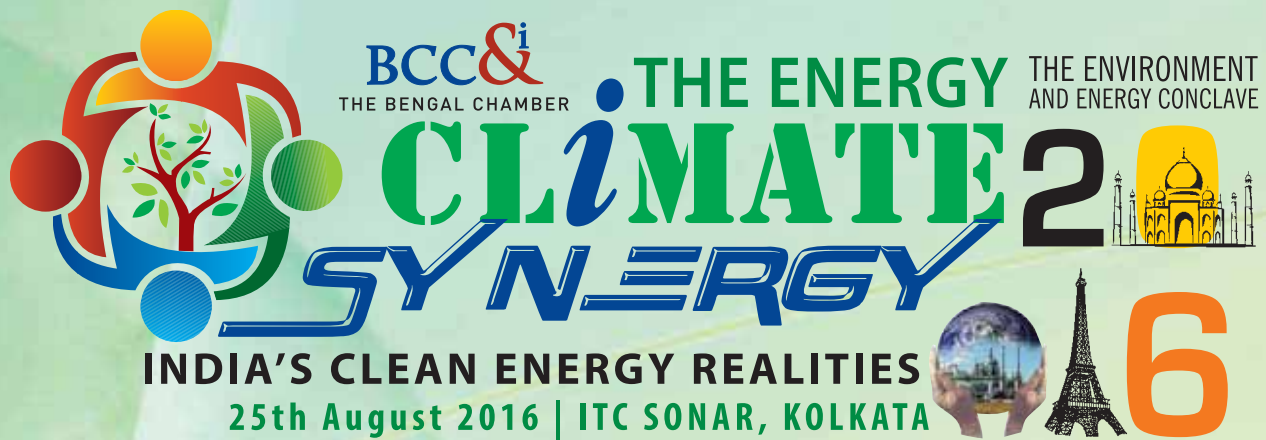

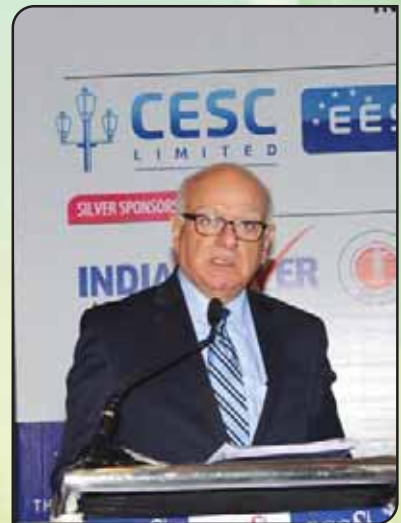

 - Scheduling and operating the grid with more renewable power which has very low / insignificant variable cost but may be intermittent in nature
 - Use of high-end technology (smart smarter) to manage grid
 - Microgrids
 - Changing business model with introduction of grid level storages
- Operations of Distribution Business
 - Lesser focus on centralized generation being taken to the point of consumption and increasing focus on small sized distributed generation close to the point of consumption
 - Technology enabled changes beyond the metering point – change in the overall demand pattern
- Demand Response / Virtual Power Plants (VPP) / Low cost Distributed Generation
- Energy efficiency tools – individually or collectively
- Innovations in Storage – Transforming Energy Business

Innovations and disruptions in the energy paradigm which are expected to be the game changer for the future were discussed. Just as the shale gas and oil revolution burst onto the scene in the new millennium reshaping the global energy landscape, distributed generation is approaching critical mass. As more and more industrial, commercial, and even

residential consumers install their own generation—be it roof-mounted solar panels, gas-fired combined heat and power (CHP) plants, or even conventional diesel backup generators—they get the opportunity to sell power into the grid. This has originated the new concept of ‘Prosumers’, an increasingly important actor in India’s urban scene who could help the country reach its ambitious goal of 40 GW of rooftop solar power capacity by 2022. For major cities in developing countries, the prosumer could be an essential ingredient in meeting the growing need for electricity.

Similarly, the disruption in the fuel economy with electric vehicles or the new-age solar roof tiles powering homes and new storage technologies are all transforming energy businesses and indeed the way of life. More than ever, digital technology has increasingly been making its way into the power generation, transmission, and distribution sectors.

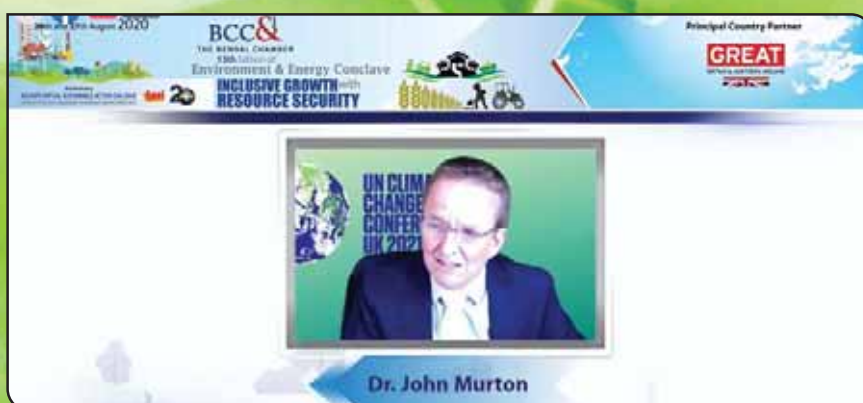

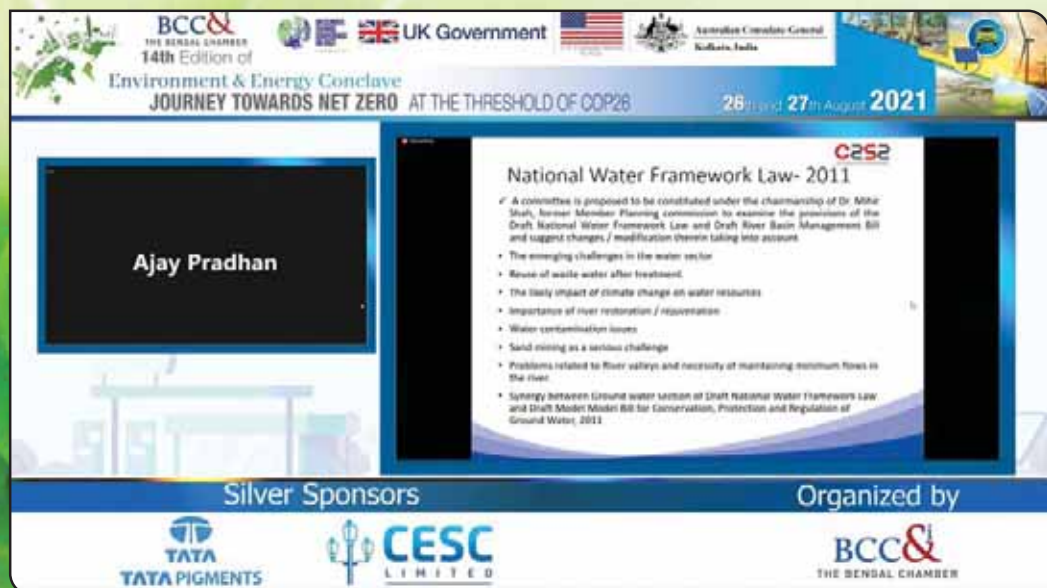

Australia has passed the country's first climate target updates while India and Egypt have updated their Paris Agreement pledges in preparation for COP 27. The Australian House of Representatives moved to pass a new bill including legally binding emissions reduction targets for 2030 and 2050. The United States and Egypt launched a joint group to prepare for COP 27. Focus is for concerted efforts to cut carbon dioxide emissions by a minimum of 45% by 2030 to be able to reach a pollution-neutral planet by mid-century. USA and Australia were present at the Conclave to share their views.
