Dr. Amit Mitra, a renowned economist, is now the Principal Chief Advisor to the Honourable Chief Minister and Finance Department, Government of West Bengal, in the rank of a Cabinet Minister of the State. He Chairs the State Level Banking Committee of the State. Dr. Amit Mitra is the Vice Chairperson of the State Public Policy and Planning Board. Dr. Amit Mitra joined Trinamool Congress and was appointed as the first Finance Minister in the Cabinet of Chief Minister, Mamata Banerjee, in 2011 and was re-elected in 2016, & he continued to hold the Finance Portfolio for the 2nd term. In addition to holding the portfolio of Finance, he was appointed as the Minister of Industry and Information Technology, along with Micro, Small & Medium Enterprises. However, he decided not to contest the Assembly Election of 2021, but was appointed by Chief Minister, Mamata Banerjee as her Principal Chief Advisor, with Cabinet Rank. Dr. Mitra had Chaired the highest body of Finance Ministers of all States of India, the Empowered Committee of State Finance Ministers, during the crucial inception of GST in India & became a Member of the National GST Council. Dr. Mitra also served on the Boards of GAIL (India) Ltd, the largest gas transmission and marketing company in India and also on the Board of IFCI, one of the largest financial institutes in the country. He was on the board of the Unit Trust of India (UTI) and the Advisory Board of Microsoft, India, as well. Dr. Mitra represented India in the India-China Eminent Persons' Group and India-EU Roundtable on Track II Diplomacy. He was also on the High Power Committee of India-USA, Defence Technology Transfer, at the Track II level. Dr. Mitra received his B.A (Hon.) from Presidency College, his Master's degree from the Delhi School of Economics and his PhD (Eco.) from the Duke University, in the USA. The Government of India conferred its civilian award Padma Shree on him in 2008. He received the highest civilian honour from the Emperor of Japan, the "Order of the Rising Sun", in 2005 & was awarded the Highest Civilian Award from the President of Italy in 2007.

Mr. Nakagawa Koichi, currently the Consul General of Japan in Kolkata, has had an illustrious career in diplomacy since joining Japan's Ministry of Foreign Affairs (MOFA) in 1987. Born in Kyoto Prefecture on July 26, 1961, Mr. Nakagawa graduated from Kinki University's Faculty of Economics in 1985. Over the years, he has held several key positions in Japan's diplomatic service. His early career began as Vice-Consul at the Consulate General of Japan in Pretoria, South Africa. In 1991, he became an official in the Multilateral Economic Cooperation Division at MOFA. In 1995, he joined the Secretariat of the International Peace Cooperation Headquarters within Japan's Cabinet Office, reflecting his growing role in international affairs. By 1998, he was appointed Assistant Director of the First International Economic Division at MOFA, furthering Japan's global economic engagements. From 2006 to 2007, Mr. Nakagawa served as Deputy Director of MOFA's Osaka Liaison Office, followed by an assignment as First Secretary at the Permanent Mission of Japan to the United Nations. In 2013, he took on the role of Deputy Director in the Economic Policy Division at MOFA. His diplomatic journey continued with his appointment as Principal Deputy Director of the Multilateral Cultural Cooperation Division in 2016, and later, Assistant Secretary General at the Secretariat of the Ceremony of Enthronement in 2018. In 2019, he was entrusted as Director of the Official Guests Division within MOFA's Protocol Office, before moving to Los Angeles in 2020 as Deputy Consul General. Since 2022, he has been serving as the Consul General of Japan in Kolkata, where he continues to foster Japan's diplomatic and economic ties, especially within the Indo-Pacific region.

Dr. Rupa Chanda is the Director of the Trade, Investment, and Innovation Division at the UN Economic and Social Commission for Asia and the Pacific (UNESCAP) in Bangkok. She leads the Commission's work on trade policy and facilitation, foreign investment, and inclusive and sustainable business in the Asia-Pacific region. Before joining UNESCAP, she was a Professor of Economics at the Indian Institute of Management (IIM) Bangalore for over 25 years and RBI Chair Professor from 2016-2021. She held various administrative positions at IIM Bangalore, including Dean of Programmes, and taught courses on Macroeconomics and International Trade in the MBA and PhD programmes, respectively. Earlier, she has also worked as an Economist at the IMF in Washington, DC and briefly served as Head, UNESCAP Subregional Office for South and South-West Asia in New Delhi. Prof. Chanda obtained her PhD, MPhil and MA from Columbia University and BA in Economics from Harvard University. She has received several research grants, including from the British High Commission, the European Commission, and Govt of India's Ministry of Finance and Ministry of Commerce. She has over 200 publications in the form of journal articles, edited book chapters, reports and working papers, as well as popular media, covering the areas of services trade, globalization of health, the WTO, Free Trade Agreements, and mobility. She has also authored two seminal books on services in India and South Asia, and co-authored/edited 5 other books in her field. Prof. Chanda has professionally engaged with international organizations such as the WTO, World Bank, WHO, UNDP, ADB, ILO, OECD, among others and with several Indian policy research institutes. She is a recognized expert in services trade and has represented the Government of India in various international forums. Her contributions to trade policy have featured in India's trade negotiations and position papers. She has been a member of various committees of the Government of India and Indian industry chambers. She was selected by the WHO as an international expert for its International Health Regulations Review Committee. She has received teaching awards during her tenure at IIM Bangalore.
