Consequent to the ever-rising oil prices, following the reverberations of the Russia-Ukraine war, India has been experiencing steep inflation rates. This in turn is affecting the country's growth rate which has been projected to slow down to 7.5% by the World Bank for the financial year 2022-23. In response, the RBI has decisively hiked the repo rate by 50 basis points, which is a second hike in as many months. Despite the apprehension of hampering economic growth and having to choose between stability and growth, this move could very well be the key to restrain inflationary pressures on the country's economy.

The Nation is also witnessing massive pressure on the Rupee and the RBI has subsequently taken quick and efficient measures by intervening in the foreign exchange market to prevent the Rupee from depreciating further. This depreciation has however inflated India's import bills leading to an increase in the trade deficit, but India seems to be addressing this through building effective trade partnerships. India's talks for a possible FTA with UK and EU and the country becoming a part of the Indo Pacific Economic Framework are significant developments. India recently also took part in the G7 meet on climate and energy, emphasizing how energy access should not be limited to the rich. Oil price hikes, the pandemic

and war may be straining economies all over the world, but India has surmounted economic obstacles even in these trying times.

There is a silver lining in the fact that the rate of unemployment has cooled down to 4.2% and the RBI has announced that there is very low risk of stagflation in India. The country has done well in navigating income shocks as per an SBI report. Also, the fact that the GDP growth rate is at a 22-year high at 8.7% is a testimony to the future prospects of India's economy.

As you would find from this edition of the newsletter, The Chamber had yet another activity filled couple of months since I wrote to you last. I would once again like to thank our Expert Committees for having organised unique workshops, training sessions, awareness programmes, seminars and conclaves of immense interest and relevance. The enthusiasm I am sure will continue in the coming months.

The International Trade Committee of the Bengal Chamber has recently organised an online workshop on “Customs Regulation” on 5th May 2022; on Zoom.

With the acceptance and ratification of TFA by 154 countries, who are members of WTO, there are critical changes in the entire operations of Customs Department including faceless and paperless assessment. Online application of Drawback and RoDTEP, filing of documents electronically on ICE gate & operationalization of E-sanchit etc. requires conceptual clarity as well as procedural expertise. Similarly, there are changes in the customs law including **Compulsory Compliance Requirements and Post Clearance Audit**.

An exporter / importer normally relies on external agencies for clearance of goods. However, ultimate responsibility lies with the exporter / the importer. It was therefore extremely important for all companies dealing in International Trade to get complete idea of operational issues. On the basis of this requirement the workshop on “Customs Regulation” was organised by the International Trade Committee of the Bengal Chamber

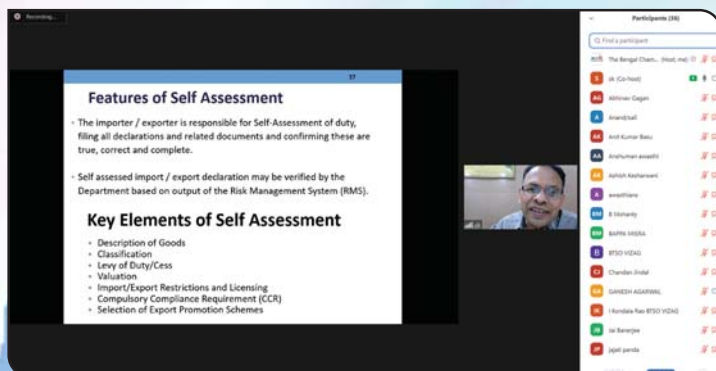
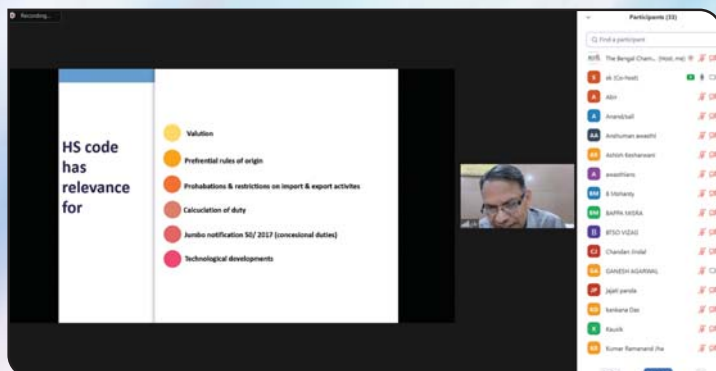

ROUNDTABLE DISCUSSION ON “RUSSIA-UKRAINE :
DYNAMICS OF GEOPOLITICS”

The Bengal Chamber of Commerce and Industry organized a **Roundtable Discussion on “Ukraine : Dynamics of Geopolitics”**, with **Air Chief Marshal (Rtd.) Arup Raha**, Honorary Member and Ambassadeur Extraordinaire, The Bengal Chamber and President, CENERS- K, on 5th May 2022 in The Bengal Chamber premises.

Dr. Nilanjan Ghosh, Director, Centre for New Economic Diplomacy & ORF Kolkata Centre, Observer Research Foundation moderated the discussion forum.

The following discussions on Russia-Ukraine : Dynamics of Geopolitics, were made during the session :

The Russia-Ukraine war has generated a climate of fear rooted in Cold War geopolitics of mutual “mistrust” between Russia and the West. There are apprehensions that it may even extend up to the Indo-Pacific region.

India had taken a neutral, stance, born of its historic strategic partnership with Russia. This alliance is spread over several fronts—diplomacy, nuclear energy, and — making Russia a pivotal part of India’s nation-building process.

Indian banks have small exposure to the two warring countries; but oil price surge above \$100/bbl mark could impact India's current account deficit and inflation. A major setback for global economic growth has taken in place as Russia is one of the largest exporters of crude oil globally. India’s trade, however, comprises only 1% oil imports from Russia, but there

could be a spillover impact in the form of high inflation and sluggish growth.

Reserve Bank of India is giving extra ammunition to seek dominance in the changing world order as alternate payment and settlement mechanisms are explored. Russia’s disconnect from trading partners in the world has created a void, which India would be able to fill in terms of exports.

With the increase in sanction against Russia, more opportunities are likely to open for India, for not only traditionally traded items, such as, pharmaceuticals; tea; rice etc, but also in newer areas like medical devices; software and hardware; transport, machinery; mobile and telecom devices; chemicals; textiles; leathers; ceramic and agriculture.

The proposed Rupee-Ruble payment mechanism could settle payment in non- dollar currencies among interesting jurisdictions of BRICS and SAARC Countries.

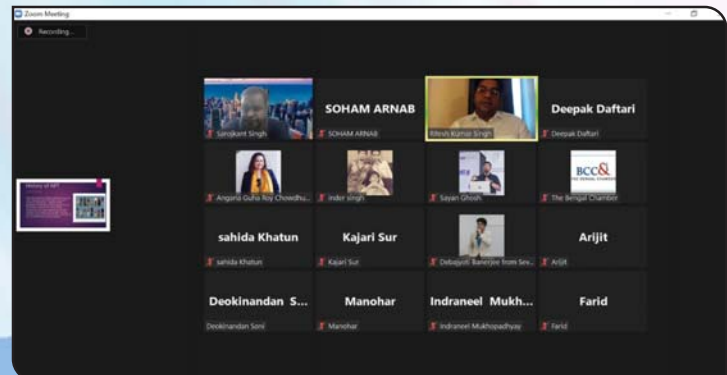
The Bengal Chamber of Commerce and Industry organized “NFT Masterclass” on 25th June 2022, virtually.

MSME DAY 2022 CELEBRATION

The 74th Plenary of the United Nations General Assembly adopted the resolution to observe June 27 as the MSME Day. MSMEs play a crucial role in achieving Sustainable Development Goals (SDGs). The day is celebrated to shine the focus on MSMEs and their contribution to global economy. MSMEs account for 90% of businesses, 60 to 70% of employment and 50% of GDP worldwide.

The Bengal Chamber and MSME DI celebrated the day on June 27, 2022 at the Chamber premises in association with Tata Steel. The celebration was aimed at, Exploring Digital Platforms for Enhancing Businesses and Facilitating Credit Linkages.

While addressing the celebration, the Chief Guest of the programme, Shri Rajesh Pandey, IAS, Principal Secretary, MSME & Textile, Govt. of West Bengal said that MSME sector in West Bengal has attracted record investment over 1.4 lakh crore in the last fiscal. The investment has resulted huge employment generation in the State. He added, "In the last financial year the MSME sector has got a bank credit of Rs. 1 crore, which was an all time record. This was the highest lending to MSME and considering that we are recovering from a pandemic, it is an achievement." However, he expressed his concerned and said "Despite the huge credit disbursed by the banks there are MSMEs mostly in districts which faced trouble in getting loans from banks. In many cases the reasons of disapproval of loans were not clear to the applicants." The banks have not yet decided the credit target for the current fiscal, however, Shri Pandey said that should be 20% more than what was achieved last year.

Integration of MSMEs into the global value chain, strengthening regional innovation systems, and establishing a multipurpose science and technology commission are of utmost importance for breaking the barriers. This would help the country in many ways including generation of employment, boosting income, improving productivity, said Mr. Sanjay Behera, Chairperson, Manufacturing & MSME Committee of The Bengal Chamber and Chief of Sales, Tata Steel. He also mentioned how the government has especially mandated that banks to achieve a 20% year on year growth in credit to micro and small enterprises. While delivering the theme address Mr. Behera said, "MSMEs account for 27% of country's GDP and 45% of the country's export and hence the growth of the sector is crucial for country's overall development."

While speaking on one of the theme areas of the programme, "Role of E-platforms in Solving Growth Challenges for MSMEs" Ms. Madhura Sekhsaria, Head - Partnerships, TATA Business Hub said that by harnessing technology MSMEs can expand their roles in global supply chains while becoming globally

competitive. Explaining the significance of E-platforms she added that digital platforms can help MSMEs do so by solving their challenges and optimising required processes to grow their businesses nationally and internationally through setting up a trusted digital presence and connecting them to customers that were earlier beyond their reach. Building a strong digital identity, through the right channels can help MSMEs broaden their reach and thus expand their businesses. For solving the aforementioned challenges, technology can enable easier and quicker access to credit digitally in comparison to offline credit. A very large proportion of MSMEs often get rejected when they apply for working capital credit, and even when they are eligible, the process for the same can be extremely cumbersome and that is where technology plays the role of messiah.

Credit Linkage for MSMEs was another focus area of the programme. Shri Bhanu Prakash Verma, General Manager, Small Industries Development Bank of India (SIDBI) said that considering the challenges and disruptions created by COVID, SIDBI has launched various financial schemes for MSMEs to support them in addressing the challenges. He mentioned about the Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) to overcome the difficulties faced by the first time entrepreneurs with no collateral. He informed the MSMEs present in the audience that rejection of proposal for credit has been a big problem and to address the problem SIDBI has started PSP 59 Portal through which MSMEs may approach any bank of their choice for sanctions of loan digitally.

Mr. Maneesh Sinha, Senior Vice President, HDFC Bank emphasized on digitization on availing bank credit for businesses. He said, "Most of the business entities HDFC is associated with are now digitally active and this is how business share and employee volume may be grown for everyone. Our customers are digitally active. We have grown significantly in this sector. Our consistency across portfolios is remarkable. People are looking at quick disposition of transparent applications; all of their questions are transparently answered." He also said that MSMEs get concessions but HDFC bank also gives them a host of their own benefits. During Covid our business affiliations went up because applicants need to come to the bank, they could do it online.

Shri Debabrata Mitra, IEDS, Director and Head of Office, MSME Development Institute, Kolkata, Government of India in his concluding remarks informed the audience about the various schemes that are available for the MSMEs.

The Inaugural session was followed by the technical sessions. The first technical session was, "Exploring Global Market by Leveraging E-platforms." In this session, Mr. Praveen Kumar

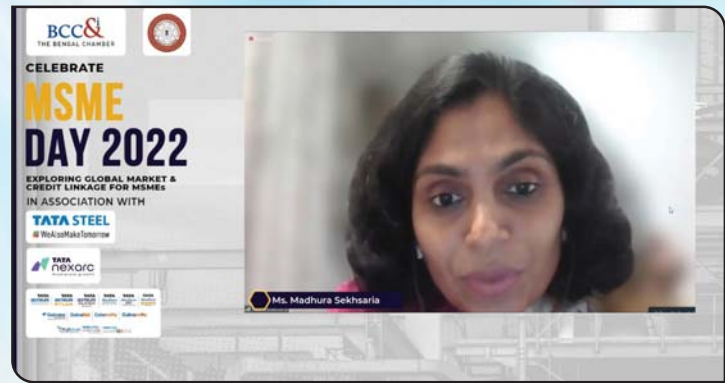

The tracks for presentation were as follows:

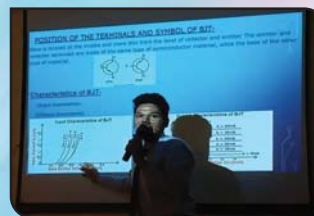
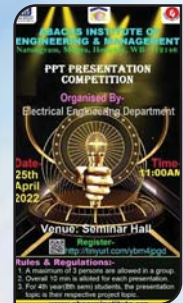
- 1) Power Electronics Devices and Applications

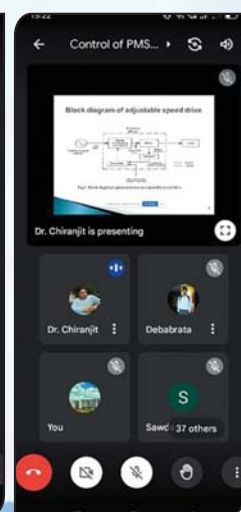
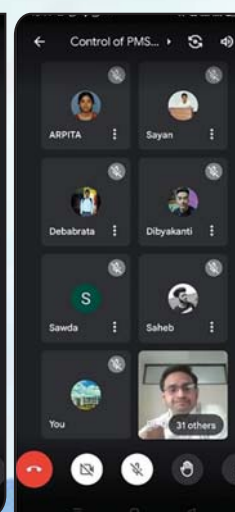
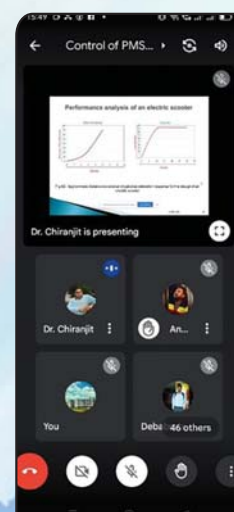

The program started on May 05, 2022, at 06.00 pm by welcoming all. The result of this program :

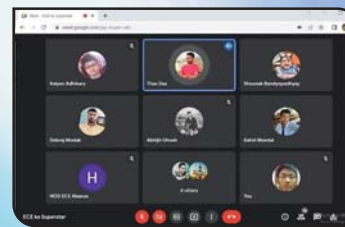

Industry Institute Interaction Session : 11/05/2022

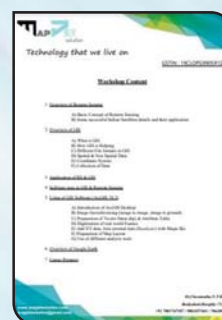

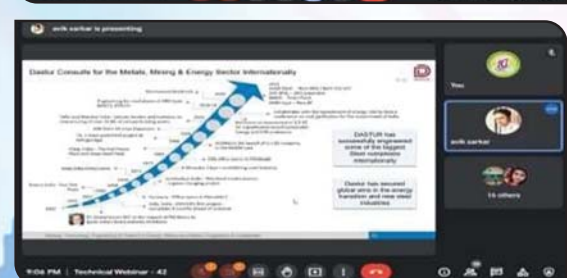

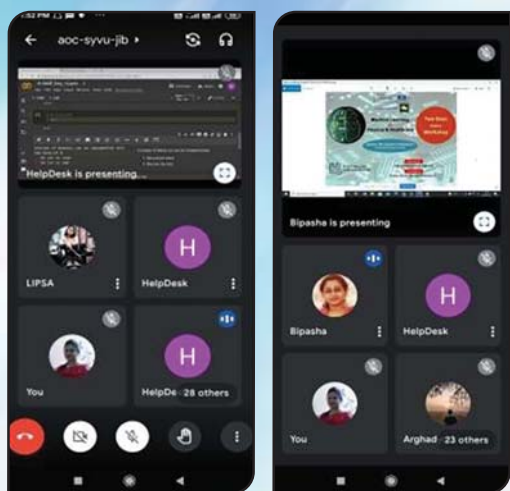


Workshop on 'ML in Health Care & Finance Sector'

2. Intra Departmental Quiz Competition @ AEIE

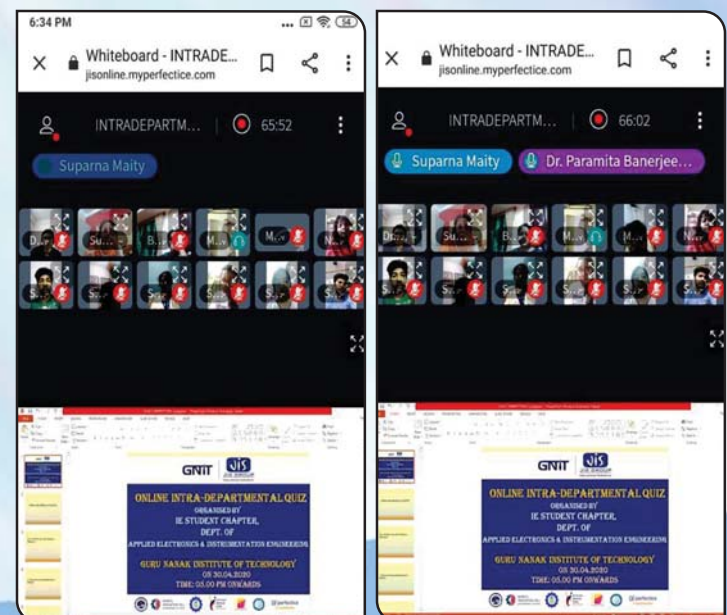

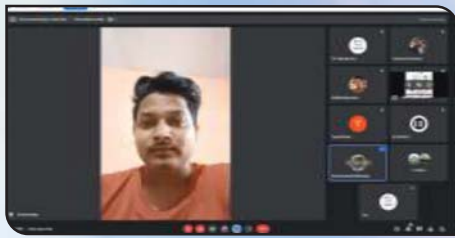
Workshop on Introduction To The Mechanical Laboratories

All the students appreciated & got benefited by the sessions which really helped them to learn a new thing.

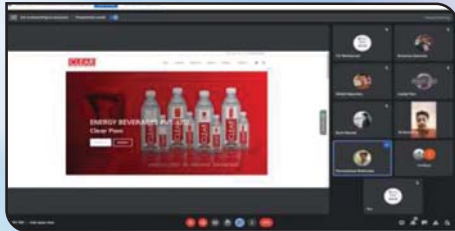

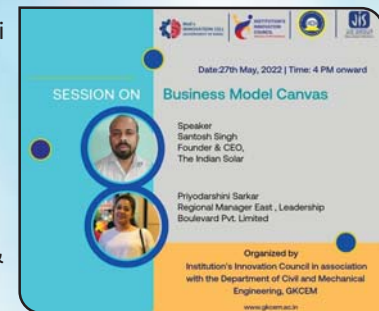
